### Election of Regional Representatives and Councillor for 2010-2011

To:- All Societies, Regional Representatives and Individual Members of the Region

1. I hereby give notice that in accordance with the Byelaws made by council for the conduct of Regional General Meetings. The Annual General Meeting of this Region for the period 2010-2011 will be held at Loughborough Town Hall in the Council Chamber on Sunday 9<sup>th</sup> May 2010 at 4.15pm.
2. In order to comply with Rule 25 of the Association, Regional Representatives must be elected to the Regional Committee each year at the Annual General Meeting of the Region. This rule also states that Regional Representatives who seek re-election shall be deemed to have been duly nominated, and no further action need be taken by Societies or Individual Members, unless they wish to nominate someone else. If a nomination is made for someone other than the existing Regional representative, it must be supported under Rule 25a by the equivalent of fifteen votes. Each Society has five votes, each Individual Member one vote, and Joint Members two votes.
